# Global Diplomatic Council Privacy Statement



*We kindly request you to read our Privacy Statement carefully. Please sign below to indicate that you have read and agree to the terms of the Privacy Statement.*

In this privacy statement, the GDC explains which personal data GDC collects, how the data are used and for what purpose.

We provide membership services to your company or organization and the employees within that company. As a result, we must have limited personal data in order to be able to provide our services. GDC finds it important to handle your personal data with care. Your personal data are therefore properly processed and secured. GDC adheres to the requirements of the General Data Protection Regulation (AVG). Because the data processing operations by GDC fall within the statutory exemption regulations, they are not registered with the Dutch Data Protection Authority.

#### *Personal Data Processed by Global Diplomatic Council*

GDC processes your personal data when you use our services and/or because you have provided us with your personal data. Below is an overview of the main types of personal data processed by AmCham:

- First and last name
- Professional affiliation
- (Company or Organization ) address
- Phone number
- (Work) e-mail address

The above data are primarily linked to your company's or organization membership profile. GDC does not record matters such as religion, race, health, sexual orientation and the like.

#### *GDPR Statement*

The General Data Protection Regulation imposes requirements on companies that collect or store personal data of residents of the European Union. At GDC, we understand the importance of your personal data and we take steps to protect the data when stored in the cloud or other infrastructure. We have adopted a number of measures to ensure that members/relations of GDC and their data are treated in a manner that is consistent with privacy principles.

GDC will not sell or provide your information to third parties and will only provide this information to third parties if this is necessary for the execution of our agreement with you or to comply with a legal obligation. With companies that process your data on our behalf, we conclude a processing agreement to ensure the same level of security and confidentiality of your data. GDC remains responsible for these processing operations.

These photos and video materials can be published on GDC website and social media channels, in the GDC Newsletter or in GDC presentations (digital or printed) to report on or to promote our activities.
